FINALISTS ARE INVITED TO HOST AN ONSITE VISIT. FINAL EVALUATION OF APPLICANTS OCCURS IN MARCH, AND GRANTS ARE AWARDED IN APRIL OF EACH YEAR. STUDENTS THEN FOLLOW UP WITH GRANTEEES AT SIX-MONTHS AND TWELVE-MONTHS AFTER THE GRANT AWARD DATE.
